- Funds must be shown at the current USD conversion rate.
- As an option, you may instead submit a bank letter on official letterhead containing the name of sponsor, relationship to the applicant, name of the applicant and the U.S. dollar amount available for the purpose of the applicant's studies.
- Government or other sponsoring agency: A signed copy of the scholarship or award letter stating the amount, name of recipient and duration of award.

 - Real estate
 - Investments, stocks or other accounts from which money cannot be withdrawn
